* Failure to perform the not less than \$100 worth of labor must be performed (i) improvements made on a mining claim annually to hold the possessory right to the claim. The period in which the work is required to be done commences at 12:00 a clock Meridian on the first day of September succeeding the date of location of the claim. Oregon law 2085 517 2108 requires that proof of the performance of labor or making of improvements must be made by affidavit filed in the mining records of the county in which the mining claim is located, within 30 days after the performance of labor or making of improvements.
