QUITCLAIM DEED

UNITED STATES OF AMERICA

TO THE

BURLINGTON NORTHERN RAILROAD COMPANY

of Aucast, nade and entered into this 26 TH day of Aucast, 1997, by and between the UNITED STATES OF AMERICA, acting by and through its Secretary of the Army and BURLINGTON NORTHERN RAILROAD COMPANY, a corporation organized and existing under the laws of the State of Delaware,

WITNESSETH:

WHEREAS, the United States of America has, under authority of Public Law 75-329 (50 Stat. 731) approved 20 August 1937 (16 U.S.C. 832), undertaken the development of a hydroelectric project known as Bonneville Lock and Dam Second Powerhouse on the Columbia River in Washington and Oregon which necessitated abandonment of portions of the right-of-way and the relocation and reconstruction of Burlington Northern's tracks and facilities; and

WHEREAS, the United States of America and Burlington Northern Railroad Company and Portland, and Seattle Railway Co. entered into Contract No. DACW57-76-C-0240 dated 2 July 1976 as modified, defining the rights and obligations of the parties relating to said abandonment, relocation and reconstruction; and

WHEREAS, Burlington Northern Railroad Company has succeeded to all rights of Spokane, Portland, and Seattle Railway Co.; and

WHEREAS, under Article 2 K(1) of said contract, the United States of America is now obligated to convey to the Burlington Northern Railroad Company by quitclaim deed all real property necessary for the construction, maintenance and operation of said relocated facilities and appurtenances thereto, including all of the real property within the right-of-way and property line shown on the plans referred to in Article 1 of said contract; and

WHEREAS, said railroad tracts and facilities have been relocated in accordance with the provisions of said contract;

NOW, THEREFORE, the United States of America, acting by and through its Secretary of the Army, pursuant to the authority in him vested by the provisions of Section 2 of the Act of Congress approved 20 June 1938 (52 Stat. 804; 33 U.S.C. 558b) as amended by the Act of Congress approved 11 August 1939 (53 Stat. 1414; 23 U.S.C. 558b-1) does by these presents remise, release, and forever quitclaim and convey unto said Burlington Northern Railroad Company, its successors and assigns, all of the grantor's title rights, and interest in and to:

First - The land in Skamania County, State of Washington described in Exhibit "A", consisting of 3 pages, attached hereto and by this reference made a part hereof.

<u>Second</u> - All permanent railroad facilities of whatever kind or nature constructed on or appurtenant to the land described in said Exhibit "A".

SUBJECT TO the following:

Patent reservations, Indian Treaty rights, existing easements for public roads and highways, public utilities and pipelines.

EXCEPTING AND RESERVING, however, unto the United States of America:

1. Fee interest in a parcel of land containing a well site as described in Exhibit "B", attached hereto and by this reference made a part hereof;

- Fee interest in three parcels of land containing Electronic Distance Measuring Trilateration Survey System sites as described in Exhibit "C", attached hereto and by this reference made a part hereof;
- 3. All rights heretofore acquired by documents now recorded in the deed records of Skamania County, Washington by the United States of America, Department of Energy (formerly Department of the Interior), acting through the Bonneville Power Administration for the powerlines and other fixtures appurtenant thereto across the right-of-way described in Exhibit "A", and that all the terms and conditions contained in said documents shall remain in full force and effect;
- 4. All rights heretofore acquired by documents now recorded in the deed records of Skamania County, Washington by the United States of America, Department of Agriculture, acting through the U.S. Forest Service for the Pacific Crest Trail and other appurtenances thereto across the right-of-way described in Exhibit "A", and that all the terms and conditions contained in said documents shall remain in full force and effect;
- 5. A perpetual and assignable access easement as described in Exhibit "B" strictly for access to and maintenance or repair of the well site;
- 6. A perpetual and assignable easement as described in Exhibit "B" for the operation, maintenance, and repair of an underground water pipeline;
- 7. A perpetual access easement over the southeast quarter of the southwest quarter (SEXSWX) of Section 15 and the southeast quarter of the southeast quarter (SEXSEX) of Section 16, Township 2 North, Range 7 East, Willamette Meridian, Skamania County, Washington for maintenance of the Trilateration sites and for taking measurements and readings with the Trilateration Survey equipment.

TO HAVE AND TO HOLD the above described and conveyed property, together with all and singular the tenements, hereditaments, and appurtenances thereunto belonging, unto said Burlington Northern Railroad Company, its successors and assigns, forever.

This instrument is given pursuant to and in final performance of the obligation of the United States under said Contract No. DACW57-76-C-0240 dated 2 July 1976, as modified, to convey to the grantee the real property described in this instrument. No monetary consideration is being paid for this deed, the consideration being other lands to be conveyed.

IN WITNESS WHEREOF, THE UNITED STATES OF AMERICA has caused these presents to be executed in its name by TOGO D. WEST JR, Secretary of the Army, and the seal of the Department of the Army to be affixed hereto this JOTH day of AUGUST 1997.
