The South 104 feet of a tract of land 208 feet square, adjacent to the north line of Section 2, Township 2 North, Range 7, EWM in the Felix-Iman DLC.

Grantees and their successors shall permit no usage of the above real property which would prevent Grantor and its successors from using its water well, located on the

The herein described property cannot be segregated and sold without first conforming to the State of Washington and Skamania County subdivision laws.

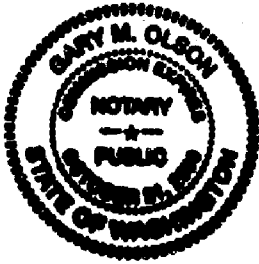
