May (Revocable)

On this day of feet, 1997, the Grantor, SKAMANIA COUNTY FIRE DISTRICT #2 ("Fire District"), for and in consideration of the sum of One Dollar (\$1.00), together with other good and valuable consideration, hereby grants to SKAMANIA COUNTY ("Licensee"), a revocable license to permit the Licensee to stockpile rock on the following described property ("Property"), to-wit:

A tract of land located in the Southeast quarter of the Northwest quarter of Section 25, Township 3 North, Range 7 East, WM, Skamania County, Washington, described as follows:

Beginning at the Northeast corner of a tract of land conveyed to R. Wilkie as described in deed recorded in Book 52 of Deeds at page 59, records of Skamania County, Washington; thence South 89 deg. 36' 00" East to the westerly right of way line of Loop Road; thence southerly along said westerly right of way line to the north right of way line of Stewart Drive; thence westerly along said north right of way line of Stewart Drive to the east line of said R. Wilkie tract; thence North 0 deg. 24' 00" East along said east line a distance of 260 feet more or less to the point of beginning;

EXCEPTING THEREFROM, that portion of said property upon which the Fire District's station is located.

- 1. Licensee shall conduct all operations in a good and workmanlike manner so as to minimize any interference with the Fire District's use of the Property or damage done thereto.
- 2. Licensee shall have the right to access, alter, repair, prepare, or modify the Property to a condition that will permit the Licensee to use the Property for the purposes set forth in this agreement. Licensee will clean up the site to the Fire District's satisfaction at the end of the project, grading any remaining rock around in the used area.
- 3. This license shall begin upon the execution hereof and shall continue until 11:59 o'clock p.m. on December 31, 1997.
- 4. Licensee shall indemnify and hold the Fire District harmless against any claims for damages to the subject property or injury to third persons resulting from or arising out of the Licensee's use of the Property.
- 5. Licensee shall not use any rock materials contaminated with hazardous materials, and shall indemnify, defend, and hold the Fire District harmless in the event of any breach hereof.
- 6. This agreement shall constitute the entire agreement between the parties and any understandings or representations of any kind preceding the date of this agreement shall not be binding upon either party except to the extent incorporated herein.
- 7. This agreement shall be governed by, construed, and enforced in accordance with the laws of the State of Washington and any actions taken to enforce or defend the terms hereof will be initiated in a court of competent jurisdiction within Skamania
