**AMENDMENT TO COVENANTS, CONDITIONS AND RESTRICTIONS
OF
THE GARY HEGEWALD SHORT PLAT #2**

Recorded at Book 167, Page 620, records of Skamania County Auditor

The Declarants hereby adopt the following amendment to the covenants, conditions and restrictions of the Gary Hegewald Short Plat #2 by adding a paragraph 2.1 as follows:

2.1 Temporary Structures. Mobile homes or camp trailers may be parked on individual lots on a temporary basis with the written consent of the Seller/Developer, provided the same is done after the acquisition of, and in compliance with, a building permit for a single family residence issued by the appropriate governmental agency, and it shall not remain longer than 12 months from the date the building permit was issued.
