DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated February 28, 1995, executed and delivered by Green Life Japan, Inc. aka Green Life Inc., a Japanese corporation, as grantor and recorded on March 8, 1995, in the Mortgage Records of Skamania County, Washington, in Book No. 148 at Page 583, in Auditor's File No. 121777, conveying real property situated in that county described as follows:

having received from the beneficiary under the trust deed a written request to reconvey, reciting that the obligation secured by the trust deed has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to the described premises by virtue of the trust deed.

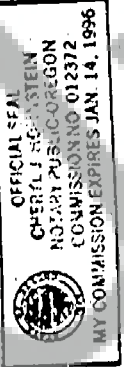
