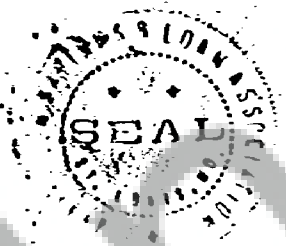

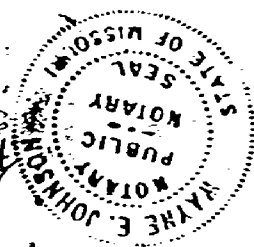

EXHIBIT "A"

A tract of land located in the Southwest quarter of the Northwest quarter of Section 34, Township 2 North, Range 6 E.W. M., described as follows:

Beginning at a point marking the intersection between the Northerly line of Primary State Highway No. 8 and the South line of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of the said Section 34; thence turning an angle Northwesterly and running on a course having an angle of $58^{\circ}30'$ with the Northerly line of said Highway a distance of 100 feet; thence in a Northeasterly direction along the Westerly side of an old abandoned County Road a distance of 200 feet to a point which is 172 feet distant Northwesterly from a point of said highway which is north $58^{\circ}01'$ East 200 feet from the point of beginning; thence Southeasterly 172 feet to the above mentioned point on said highway; thence South $58^{\circ}01'$ West 200 feet to the point of beginning; TOGETHER with an easement for a water pipeline as described in deed dated July 3, 1947, and recorded August 26, 1947, at page 475 of Book 31 of Deeds records of Skamania County, Washington.
