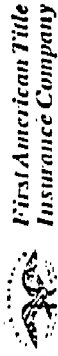

KNOW ALL MEN BY THESE PRESENTS, That

has made, constituted and appointed, and by these presents does make, constitute and appoint

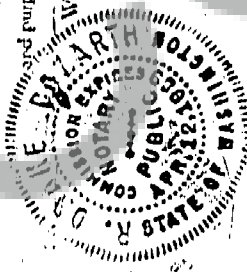
