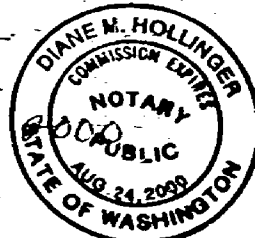

A tract of land in the south half southwest quarter (S $\frac{1}{2}$  SW $\frac{1}{4}$ ) Section 22, Township 2 North, Range 6 East, W.M., in Skamania County, Washington and described as:

Beginning at a point on the south line of said south half southwest quarter N 89-21-31 W, 125.00 feet from the southeast corner of the southwest quarter southwest quarter (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ) of said Section 22; thence N 01-11-07 E, parallel with the east line of said southwest quarter southwest quarter, 450.01 feet; thence S 89-21-31 E, parallel with the south line of said south half southwest quarter, 468.68 feet to the centerline of County Road No. 1014 designated as the Woodard Creek Road; thence following said centerline along the arc of a 1226.60-foot radius curve to the left (the incoming tangent of which is S 16-18-08 W) for an arc distance of 102.77 feet; thence leaving said center line (at a point 350 feet N 01-11-07 E of the south line of said Section 22), N 89-21-31 W parallel with said south line, 321.07 feet to the east line of said southwest quarter southwest quarter; thence S 01-11-07 W along said east line 350 feet to the south line of said Section 22; thence N 89-21-31 W along said line 125 feet to the point of beginning.
