SECTION 23: The SW4SW4, LESS AND EXCEPT that certain tract of land conveyed to Pacific Power & Light Company as described in Warranty Deed dated October 24, 1960, recorded March 2, 1961 in Book 48 at Page 352 under Auditor's File No. 58170;
