

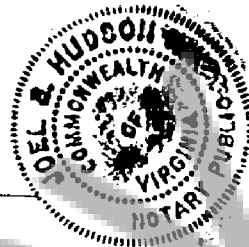


EXHIBIT A
PARCEL B

A parcel of land situated in the NW 1/4 of Section 29, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at the 4" x 4" concrete monument with 3 1/2" brass cap found - marked "Town of North Bonneville" designated as NB-10 on the south line of the Third Addition to the Plats of Relocated North Bonneville Block 10 as recorded in Volume B of plats at Page 34 of records of said county;

thence East along the south line of said Third Addition 133.41 feet to the east line of a 150-foot wide strip of land being a causeway in use as a roadway;

thence S 03°35'50" W along the east line of said causeway 442.83 feet to the south line of a tract of land conveyed to the Town of North Bonneville by deed recorded in Book 69, Page 747 of the records of said county;

thence N 80°50'20" E along said south line of said tract of land 76.77 feet;

thence N 73°21'20" E along said south line of said tract of land 393.20 feet;

thence N 84°01'20" E along said south line of said tract of land 452.30 feet to the southeast corner of said tract of land;

thence N 02°31'10" W along the east line of said tract of land 270.26 feet to the south line of said Third Addition to the Plats of Relocated North Bonneville Block 10;

thence N 90°00'00" E along said south line of said Third Addition 267.84 feet to a point designated as NB-11;

thence S 06°40'28" E along the westerly line of said Third Addition and the southerly extension of said westerly line 585.55 feet;

thence N 70°37'49" W 89.8 feet;

thence N 66°37'53" W 109.75 feet;

thence N 71°52'12" W 132.51 feet;

thence on a 17°57'00" curve to the left with a radius of 358.62 feet, a distance of 112.33 feet;

thence N 86°51'00" W 149.46 feet;

thence S 89°23'24" W 267.84 feet;

thence S 80°26'48" W 242.95 feet;

thence S 81°42'48" W 366.84 feet;

thence N 09°34'56" W 89.04 feet;

thence N 80°50'20" E a distance of 98.34 feet along the south line of a tract of land conveyed to the Town of North Bonneville by deed recorded in Book 69, Page 747 of the records of said county to the west line of a 150 foot wide strip of land being a causeway in use as a roadway;

thence N 03°35'50" E along the west line of said causeway 434.47 feet to the south line of the Third Addition to the Plats of Relocated North Bonneville Block 10 as recorded in Volume B of plats at Page 34 of the records of said county, to the point of beginning.

The parcel of land herein described contains 7.70 acres, more or less.

PARCEL C

A parcel of land situated in the S 1/2 of Section 20 and the N 1/2 of Section 29, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at a point on the platted boundary of Relocated North Bonneville said point designated as NB-13 on sheet 5 of the Plat of Relocated North Bonneville - CBD, as recorded in Volume B of plats at page 23, of the records of said county;

thence along said platted boundary as follows:

North 425.00 feet to a point designated as NB-14 on said sheet 5;

thence West 632.70 feet to a point designated as NB-15 on said sheet 5, said point being on the easterly right-of-way line of Pioneer Drive;

thence northerly 51.10 feet along a 465-foot radius curve to the left, through a central angle of $06^{\circ}18'01''$, to a point designated as NB-16 on said sheet 5;

thence northerly 189.80 feet along a 180-foot radius curve to the left, through a central angle of $60^{\circ}24'53''$, to a point designated as NB-17 on said sheet 5;

thence N $32^{\circ}31'03''$ W 131.69 feet to a point designated as NB-18 on said sheet 5;

thence northerly 96.40 feet along a 110-foot radius curve to the right, through a central angle of $50^{\circ}12'47''$, to a point designated as NB-19 on said sheet 5;

thence N $17^{\circ}41'44''$ E 100.40 feet to a point on the southerly right-of-way line of Garrison Drive designated as NB-20 on said sheet 5;

thence S $71^{\circ}33'54''$ E 117.92 feet to a point designated as NB-21 on said sheet 5;

thence easterly 251.29 feet along a 530-foot radius curve to the left, through a central angle of $27^{\circ}09'57''$, to a point designated as NB-22 on sheet 6 of the Plat of Relocated North Bonneville - Block 6;

thence easterly 332.24 feet along a 923.91-foot radius curve to the left, through a central angle of $20^{\circ}36'12''$, to a point designated as NB-23 on said sheet 6;

thence northeasterly 427.72 feet along a 601.64-foot radius curve to the left, through a central angle of $40^{\circ}43'59''$, to a point designated as NB-24 on said sheet 6;

thence N $75^{\circ}51'15''$ E 745.41 feet to a point designated as NB-50 on sheet 10 of the Plat of Relocated North Bonneville - Blocks 8-9;

Parcel C continued ...

thence N 26°01'47" E 239.27 feet to a point designated as NB-51 on said sheet 10;

thence leaving said platted boundary, S 06°50'34" E for a distance of 201.72 feet to a point that lies northwesterly, a distance of 30 feet when measured at right angles from the centerline of the Corps Day Use Road;

thence S 36°59'00" W, parallel with the centerline of said Corps Day Use Road, a distance of 508.10 feet to the beginning of a 984.93 foot radius curve to the left;

thence along the arc of said curve to the left, parallel with the centerline of said Corps Day Use Road, through a central angle of 16°08'56" for an arc distance of 277.61 feet,

thence S 20°50'04" W, parallel with the centerline of said Corps Day Use Road, for a distance of 576.53 feet;

thence S 55°55'19" W a distance of 585.02 feet more or less to the point of beginning.

The parcel of land above described contains 25.56 acres, more or less.

NOTE: All bearings and distances are based on the Oregon Coordinate System, North Zone.
