## SPECIAL AMENDMENT for Lot 3 SOUTHRIDGE SHORT PLAT

#### DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS for ROBSON SHORT PLAT and SOUTHRIDGE SHORT PLAT

TO THE PUBLIC:

Know all Men by these Presents that the Declaration of Covenants, Conditions and Restrictions for ROBSON SHORT PLAT and SOUTHRIDGE SHORT PLAT shall be specially amended as follows:

On April 3, 1996 The Declaration of Covenants, Conditions and Restrictions for ROBSON SHORT PLAT, which included property now known as SOUTHRIDGE SHORT PLAT, was executed, said Declaration was recorded in Book 156, Page 362, under Auditor's file #124943, records of Skamania County, Washington.

Now Therefore, the Declaration of Covenants, Conditions and Restrictions for ROBSON SHORT PLAT and SOUTHRIGDE SHORT PLAT referred to above, is hereby specially amended as follows:
