TERM EASEMENT

The Grantors, SYLVIA E. RISJORD, ALICE EVELYN HAHN, and AUSTIN SAMUEL RISJORD, for and in consideration of Five Hundred and 00/100 Dollars (\$500.00), hereby grants and conveys to the STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called the Grantee, its successors and assigns, a term easement upon, over, and along rights of way 60 feet in width over and across part NW½ SW½, Section 24, Township 3 North, Range 7 East, W.M., in Skamania County, Washington, being 30 feet on each side of the centerline of a road or roads located approximately as shown on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

- The easement is conveyed for the purpose of constructing and/or maintaining a road to
 provide access to and from lands presently owned or hereafter acquired by the Grantee,
 or controlled by the Grantee, for forest land management and administration activities,
 including but not limited to valuable material removal operations.
- 2. The Grantor reserves to itself, its successors and assigns, the right to use the roadway in any manner which does not unreasonably interfere with the use of said road by the Grantee, its assigns, successors, agents, contractors, employees, lessees, or licensees. Said road users will, however, contribute their pro rata share to the maintenance costs caused by their usage so that such maintenance will leave the road in as good a condition as existed at the time of commencement of said use.
- 3. The term of this easement shall be five (5) years effective on date of signature.
- 4. Prior to the commencement of use for timber haul, State shall notify Grantors of the volume to be hauled, approximate dates of haul, and provide advance payment in the amount of \$0.25/mbf. Payment for timber volume shall be based on the State's cruise estimate


