1. That Resolution No. 239-A dated 13 day of November, 1979 directed the Engineer to review the County Road System.
2. That on 16th day of November, 1979, the Engineer did report on the matter.
3. That Resolution No. 340-A dated 19 day of November, 1979, did direct the Engineer to examine and prepare all necessary data.
4. That the Board did on 19 day of November, 1979 set the date of 17 day of December, 1979, at 11:00A.M. at the Commissioner's Room for a public hearing on the matter of these road vacations, and given by publication and posting as provided by law.
5. That on 17 day of December, 1979, at 11:00A.M., said public hearing was held and all statements and comments from the public were received, considered and recorded.
6. That the public will be benefited by the resulting actions as are set forth below.

IT IS THEREFORE ORDERED BY THE BOARD OF COUNTY COMMISSIONERS, as follows:

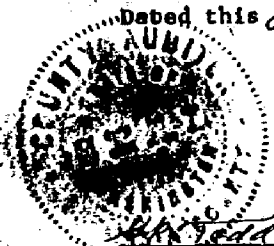
1. The County Roads or parts of County Roads as listed on attachment B of this Resolution be VACATED as of this date.

1. Provided all land owners the road is now serving will form a land owners corporation for maintaining the road as a private road. The maintenance agreement shall be in concurrence with the County Private Road Standards.
2. Provided the land owners construct a cul-de-sac at the end of Uran Road. The cul-de-sac shall have a minimum diameter of 90 feet and shall be constructed to County Road Standards.
3. The above provisions must be completed by August 1, 1980.
