Beginning at a point in the center of Wind River 110 feet in a northerly direction from the Northwest corner of Lot Ten (10) of Blaisdell Tracts, as same appears on the official plat recorded in the office of the Auditor for Skamania County, State of Washington; thence following the center of Wind River in a northerly direction in such a manner as to deed a parcel of land which will measure in a straight line fifty feet in width; thence in an easterly direction to the present west boundary line of Old County Road; thence following the west boundary line of said road in a southerly direction in such a manner as to convey a parcel of land which will measure in a straight line fifty feet in width; thence in a straight line westerly to the place of beginning.

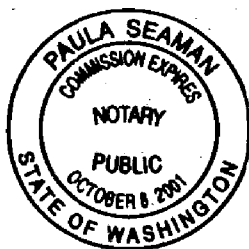
