COMMUNITY PROPERTY AGREEMENT

This agreement, made and entered into this ______ day of July, 1998, by and between STEPHEN RAY BUTCHER and KATHLEEN ANN BUTCHER, husband and wife, of Cook, Washington, pursuant to the provisions of Section 26.16.120 of the Revised Code of Washington, permitting agreements between husband and wife fixing the status and disposition of community
