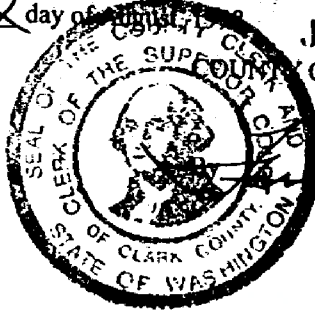

Exhibit "A"

PARCEL I

The Southwest quarter of Section 18, Township 1 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington.

EXCEPTING THEREFROM the North half of the Northwest quarter of the Northwest quarter of said Southwest quarter.

ALSO EXCEPTING THEREFROM, the Northeast quarter of the Northwest quarter of said Southwest quarter.

ALSO EXCEPTING THEREFROM Beginning at the Southwest corner of the East half of the East half of said Southwest quarter; thence North 400 feet; thence East 490 feet; thence South 400 feet, more or less, to the North side of County Road; thence West 490 feet, more or less, along the North side of County Road to the point of beginning.

EXCEPTING THEREFROM, that portion lying in County Roads.

PARCEL II

The West half of the West half of the Southeast quarter of Section 18, Township 1 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington.

EXCEPTING THEREFROM, beginning at the Southeast corner of the West half of the West half of said Southeast quarter; thence North along the East line of said West half of West half of Southeast quarter a distance of 758 feet, more or less, to a wire fence at the North line of timber (as said fence was located November 4, 1950); thence West 420 feet; thence South 758 feet to the center of County Road, and the South line of said Section 18; thence East 420 feet to the point of beginning.

ALSO EXCEPTING THEREFROM, that portion lying in County Roads.
