Notice is hereby given that Utility Helicopter Services, Inc., a Washington corporation of Whatcom County, state of Washington, claims a lien upon approximately 2,642,700 pounds of timber, being about 50 truckloads in quantity (about 250,000 board feet in quantity), which were cut or manufactured in Skamania County and more particular, within the south half of the northwest one quarter of Section 5, Township 1 North, Range 5 East, W.M., state of Washington, are marked thus "MG", and are now lying in Lewis County, Washington, Cowlitz County, Washington, Benton County, Oregon, and Clackamas County, Oregon, for labor performed upon and assistance rendered in cutting, yarding and delivering to a landing said timber; that the name of the owner or reputed owner Tim Tweet, Weyerhaeuser Company, RSG Forest Products, Inc., Reichert Shake & Fencing, Hambleton Bros. Lumber Company, Inc., and Mary's River Lumber Company; that Tim Tweet employed said Utility Helicopter Services, Inc., to perform such labor and render such assistance upon the following terms and conditions, to wit:

To provide helicopter and pilot, together with support equipment and personnel for the cutting, yarding and delivering to a landing of timber to be

paid at the rate of \$2,350.00 per helicopter flight hour, plus cutting and "flagging" costs.

The said Tim Tweet agreed to pay the said Utility Helicopter Services, Inc., for such labor and assistance \$61,479.16 (19 helicopter flight hours times \$2,350.00 per helicopter flight hour equals \$44,650.00 plus sub-contracted cutting costs of \$14,699.16 and sub-contracted flagging costs \$2,130.00); that said contract has been faithfully performed and fully complied with on the part of said Utility Helicopter Services, Inc., who performed labor upon and assisted in cutting, yarding and delivering to a landing said timber for the period of seven days; that said labor and assistance were so performed and rendered upon said timber between the 16th day of June, 1998, and the 25th day of June, 1998; and the rendition of said service was closed on the 25th day of June, 1998, and sixty days have not elapsed since that time; that the amount of claimant's demand for said service is \$61,479.16; that no part thereof has been paid and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$61,479.16, in which amount it claims a lien upon said timber. The said Utility Helicopter

Services, Inc., also claims a lien on all said timber now owned by said Tim Tweet, Weyerhaeuser Company, RSG Forest Products, Inc., Reichert Shake & Fencing, Hambleton Bros. Lumber Company, Inc., and Mary's River Lumber Company of said counties to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles, or other timber, lumber, or shingles herein described.




