AREA TO BE CONVEYED "HENDERSON" TO "CANNARD" :

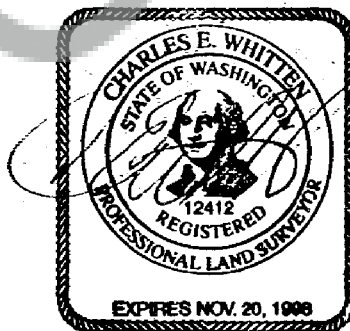
A portion of the Southwest quarter of the Northeast quarter of Section 8, Township 1 North, Range 5 East, Skamania County, Washington described as follows:

BEGINNING at a 5/8 inch iron rod marking the quarter corner between Sections 5 and 8 as noted in a "Land Corner Record" filed in Book 161 of deeds, Page 708, Skamania County Auditor's Records; thence South $01^{\circ} 31' 00''$ West, along the West line of the Northeast quarter of Section 8, for a distance of 1298.00 feet to the Northwest corner of the Southwest quarter of the Northeast quarter of Section 8, said point being the Northwest corner of the "Thompson tract" as described in Deed Book 63, page 614, Skamania County Auditor's Records; thence North $89^{\circ} 50' 42''$ East, along the North line of the "Thompson tract" and along the North line of the Southwest quarter of the Northeast quarter, for a distance of 575.00 feet to the Northeast corner of the "Thompson tract"; thence South $01^{\circ} 31' 00''$ West, 230.00 feet to the Southeast corner of the "Thompson tract" and the TRUE POINT OF BEGINNING; thence South $89^{\circ} 50' 42''$ West, along the south line of the "Thompson tract, 320.00 feet to a 5/8 inch iron rod as set in a 1998 "Hagedorn, Incorporated Survey"; thence North $77^{\circ} 35' 13''$ East, 329.56 feet to a 5/8 inch iron rod (1998 "Hagedorn, Inc. Survey") on the East line of the "Thompson tract"; thence South $01^{\circ} 31' 00''$ West, 70.00 feet to the TRUE POINT OF BEGINNING.
