This agreement made and entered into this 4th day of November, 1998, by and between RIVERVIEW COMMUNITY BANK (hereinafter called "Lender"), Mary L. Westfall, as her separate estate (hereinafter called "Owner(s)")

WITNESSETH:

WHEREAS, Lender

the sum of one hundred twenty seven thousand and no/100 dollars, (\$127,000.00), as evidenced by a note and mortgage (the term "mortgage" includes a Deed of Trust) executed and delivered on September 09, 1997, which mortgage is duly recorded under Auditor's File No. #129216 in the public records in the jurisdiction where the mortgaged property is located which note and mortgage are hereby incorporated herein as part of this instrument; and

WHEREAS, the undersigned owner of said premises has found it necessary and does hereby request a modification of the terms of said loan for the following reasons:

To alleviate the necessity of refinancing this loan on the part of the owner and to extend the maturity date on the original note dated September 09, 1997, from November 01, 1998 to May 01, 1999. NOTWITHSTANDING, all other terms and conditions remain unchanged.

and

WHEREAS, the parties desire to restate the modified terms of said loan so that there shall be no misunderstanding of the matter;

THEREFORE, it is hereby agreed that, in consideration of the reasons stated above, as of the date of this agreement the unpaid balance of said indebtedness is one hundred twenty seven thousand and no/100 dollars, (\$127,000.00), all of which the undersigned promises to pay with interest at 7.375% per annum until paid and that the same shall be payable interest only dollars, (\$interest only) per month beginning on the 1st day of November 1998. To be applied first to interest and balance to principal, plus a sum estimated to be sufficient to discharge taxes and insurance obligations, if applicable, (which estimated sum may be adjusted as necessary) and that in all other respects said mortgage contract shall remain in full force and effect.
