Karl DeLyria and Kaon Kolodzickki, or their successors and or assigns (hereinafter collectively referred to as the DeLyrias) will have the right to ingress or egress over the land adjacent to said line for the purpose of constructing, maintaining, operating, monitoring and reconstructing the water line and related facilities.

Owners, their successors and assigns, shall have the right to use and occupy the surface of said property for any purpose consistent with the rights and privileges herein granted which will not endanger or interfere with the construction, maintenance, and operation of the said water line and related facilities.
