HINZMAN and DEBORAH ANN HINZMAN, husband and wife, "Grantor" hereby grants, conveys and warrants to THE WASHINGTON WATER POWER COMPANY, a Washington corporation, "Grantee" a perpetual easement on, over, under, along and across real property identified as Assessor Parcel # 03-07-36-3-4-3000-00, located in the Southeast Quarter of Section 36, Township 3 North, Range 7 East, W.M. in Skarmania County, State of Washington, and being more particularly described as follows:

Lot 4, Block 1 of ROSELAWN ADDITION, being a portion of the Southeast Quarter of Section 36, Township 3 North, Range 7 East, W.M., in Skamania County, State of Washington.

1. PURPOSE. Grantee shall have the right to construct, reconstruct, operate, maintain, repair, relocate and replace an underground natural gas pipeline, "facilities", on, over, under, along and across the herein described property, together with all necessary facilities and appurtenances. Facilities shall be installed by Grantee as close as possible to the south line of said property. No building shall be placed within five feet (5) of the centerline of facilities.

Grantee shall have the right to cut, trim and remove any and all brush, branches and trees, including danger trees, on the above described or adjoining property of the Grantor, that in the opinion of the Grantee, could interfere with the safe and reliable operation of Grantee's facilities as described herein, or that could interfere with the exercise of Grantee's rights as granted herein.
