APPOINTMENT OF
DEPUTY PROSECUTING CORONER(S)

I, BRADLEY W. ANDERSEN, being the duly elected and acting Prosecuting Attorney/Coroner for Skamania County, State of Washington, by the powers invested in me by statute, do hereby appoint CHUCK BRYAN, Skamania County Sheriff, and each of his deputies working under him, as Deputy Coroner(s) for Skamania County, for the purpose of performing the duties of County Coroner in my absence, if and when called upon to perform such duties.
