## **DEED OF TRUST SUBORDINATION AGREEMENT**

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- 1. WASHINGTON STATE, DEPARTMENT OF COMMUNITY, TRADE, AND ECONOMIC DEVELOPMENT, referred to herein as "subordinator", is the owner and holder of a deed of trust dated February 24, 1998 and executed by COLUMBIA CASCADE HOUSING CORPORATION DBA COLUMBIA CASCADE HOUSING, an Oregon nonprofit corporation, which was recorded on February 24, 1998 in Book 173, Page 618 under auditor's file No. 130595, records of Skamania County, Washington.
- 2. WASHINGTON COMMUNITY REINVESTMENT ASSOCIATION, referred to herein as "lender", is the owner and holder of a deed of trust dated February 4, 1999, executed by COLUMBIA CASCADE HOUSING CORPORATION DBA COLUMBIA CASCADE HOUSING, an Oregon nonprofit corporation, which is recorded under auditor's file No. 134164 Vol 136 Pg 228, records of Skamania County, Washington.
- 3. COLUMBIA CASCADE HOUSING CORPORATION DBA COLUMBIA CASCADE HOUSING, an Oregon nonprofit corporation, referred to herein as "owner", is the owner of a leasehold interest in the real property described in the deed of trust identified above in Paragraph
- In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its deed of trust and all agreements in connection therewith, the "subordinator" does hereby subordinate the lien of its deed of trust identified in Paragraph ! above to the lien of "lender's" deed of trust, identified in Paragraph 2, and all advances or charges made or accruing thereunder, including extension or renewal thereof. However, pursuant to the Revised Code of Washington 43.185 et. seq., the Department of Community, Trade, and Economic Development does not subordinate its covenants running with the land restricting the property to very low income households for the term of the commitment.
- 5. "Subordinator" acknowledges that, prior to the execution hereof, he has had the opportunity to examine the terms of "lender's" mortgage, note and agreements relating it thereto and recognizes that "lender" has no obligation to "subordinator" to advance any funds under its mortgage or see to the application of "lender's " mortgage funds, and any application or use of such funds for purposes other than those provided for in such mortgage, note or agreements shall not defeat the subordination herein made in whole or in part.
- 6. It is understood by the parties hereto that "lender" would not make the loan secured by the deed of trust in Paragraph 2 without this agreement.
