Dear Mr. Olson:

Please be advised that this office represents Tracy Throw with regard to tortious conduct against her by officers of the Skamania County Sheriff's Department. This is notice of her claims pursuant to RCW 4.96.020 et seq.

Ms. Throw was damaged by actions of the Sheriff's Department in at least the following respects:

- 1) Ms. Throw was wrongfully arrested without probable cause by Sheriff's Deputies on or about July 27, 1998 while traveling in her vehicle;
- 2) Ms. Throw was wrongfully discharged from her employment with the Sheriff's Department by letter dated September 2, 1998 from Sheriff Bryan, in retaliation for exercising her First Amendment right of association and without due process of law; and
- 3) On or about June 5, 1998, Ms. Throw was disciplined by Sheriff Bryan without provision of due process.


Each of the above events occurred in Skamania County.

Amount of damages claimed is \$250,000. Damage/injury consists of lost wages and other compensation, future earnings, emotional distress, damage to reputation, injury to constitutional rights, loss of liberty, embarrassment, humiliation, and psychological damage.
