REPLACE with the following:

T. 1 N., R. 5 E., W.M.  
sec. 2, S1/2SW1/4, and the S1/2S1/2N1/2SW1/4;

ALSO, TOGETHER WITH the right of ingress and egress over existing roads.

Except as amended by this Agreement to Correct Easement Deed, the aforementioned deed is hereby confirmed and remains in full force and effect.

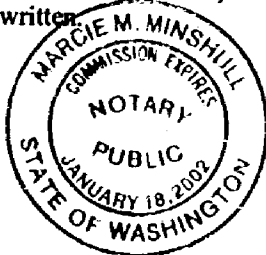

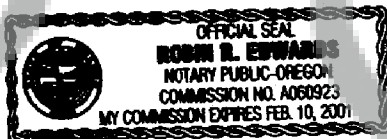
