Dear Mr. Green:

The Planning Department issued a final Director's Decision on June 18, 1998 for the above referenced application. However, subsequent to that date, you have requested a small change to that decision, that request is dated February 2, 1999, and would allow for a slight change in location and size of the addition. The change would locate the addition on the south side of the existing shed rather than the west side and would increase the size from 24' x 24' to 30' x 30'. The change is acceptable as it is a very minor change only adjusting the location and slightly increasing the size of the addition.

Pursuant to SCC §22.06.080(B), a change or alteration to an approved action, if determined to be minor by the Director, may be "deemed consistent with the provisions of this Title and the findings and conclusions on the original application." The Director has determined that the proposed request constitutes a minor change, therefore, the original decision shall be amended to allow a change in the location of the addition from the west side of the existing shed to the south side of the existing shed and also allow a slight increase in size as stated above.

All of the original conditions in the Director's Decision are still valid and shall be complied with.


