Dear Mr. Green:

The Planning Department issued a final Director's Decision on June 18, 1998 for the above referenced application. However, subsequent to that date, you requested a small change to that decision, that request was dated February 2, 1999, and allowed for a slight change in location and size of the addition. The change located the addition on the south side of the existing shed rather than the west side and increased the size from 24' x 24' to 30' x 30'. The change was acceptable as it was a very minor change only adjusting the location and slightly increasing the size of the addition.

Once that amendment was issued, however, you indicated that you had mistakenly requested the change in size to be 30' x 30' rather than 36' x 36'. This request almost doubles the size of the originally approved addition to the existing shed, however, the change is still acceptable as the location is not changing and the addition is within an already disturbed area.

Pursuant to SCC §22.06.080(B), a change or alteration to an approved action, if determined to be minor by the Director, may be "deemed consistent with the provisions of this Title and the findings and conclusions on the original application." The Director has determined that the proposed request constitutes a minor change, therefore, the original decision shall be amended to allow a change in the amended size of the addition from 30' x 30' to 36' x 36'.

All of the original conditions in the Director's Decision are still valid and shall be complied with.
