THE GRANTORS, NELS A. LINDE and HANNAH LINDE, husband and wife, for and in consideration of One Buller, Love and Affection, convey and warrant to LEONARD LINDS and NAZEL LINGE, husband and wife, the following described real estate, situated in the County of Skemenia, State of Wathington:

PARCEL NO. 1

A tract of land located in the Northwest Quarter of the Northeast Quarter (MAC NEW) of Section 26, Township & North, Range 7 E. W. M., described as follows:

Beginning at the intersection of the morth time of the said Section 26 with the center of the channel of Wind River; thence west along the north line of said section to intersection with a certain private road leading to real property formerly owned by Floyd A.
