Dear Mr. Simpson:

The Planning Depertment issued a final Director's Decision on May 4, 1998 for the above referenced application. However, subsequent to that date, you have requested a minor alteration to the exterior of the proposed house and a slight extension of the driveway (See attached request). You are requesting to construct a wrap around porch on the south and east sides of the residence and to extend the driveway approximately 50 feet in order to be able to park cars north of the home.

Pursuant to SCC §22.06.080(B), a change or alteration to an approved action, if determined to be minor by the Director, may be "deemed consistent with the provisions of this Title and the findings and conclusions on the original application." I have determined that the proposed request constitutes a minor change, therefore, the original decision shall be amended to allow for an extension to the approved driveway and to allow for a wrap around porch on the south and east sides of the approved home.

All of the original conditions in the Director's Decision are still valid and shall be complied with. This amendment does include a 20 day appeal period (see below).
