Exhibit "D" Legal Description for Robert Whitaker Boundary Line Adjustment of Lots

A parcel of property located in the Northwest quater of the Southeast quater of the Northwest quater of Section 20, Township 2 North, Range 5 East of the Willamette Meridian in Skamania County, Washington described as follows:

The South half of Tracks 364 of that Short plat recorded in Book 2 of Short Plats at page 209 of Skamania County records. Subject to an easement for ingress, egress and utilities running across and over the westely 30 feat.
