Beginning at a point 859.4 feet North and 30 feet East of the Southwest corner of the Southeast Quarter of the Southeast Quarter of Section 26, Township 2 North, Range 6 East of the Willamette Meridian, in the County of Skamania, State of Washington, thence North  $70^{\circ} 46'$  East 200 feet along the county road known and designated as Little Street; thence South  $17^{\circ} 47'$  East 167 feet; thence South  $70^{\circ} 46'$  West 251.05 feet; thence North 167 feet to the Point of Beginning.

ALSO: Beginning at a point 859.4 feet North and 30 feet East of the Southwest corner of the Southeast Quarter of the Southeast Quarter of the said Section 26, thence North  $70^{\circ} 46'$  East 200 feet along Little Street aforesaid to the initial point of the tract hereby described; thence South  $17^{\circ} 47'$  East 401.5 feet; thence East 75 feet to the center of the county road formerly designated as State Highway No. 8; thence following said county road in a Northerly direction to the intersection with the Southerly line of Little Street; thence South  $70^{\circ} 46'$  West along the Southerly line of Little Street to the initial point.
