## COMMUNITY PROPERTY AGREEMENT

IT IS FURTHER AGREED that the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once, in the event of the death of JAMES ROBERT KUSKIE, while the said DORTHA MAE KUSKIE survives, be vested in DORTHA MAE KUSKIE, absolutely and in fee simple as her sole and separate property; and, in the event of the death of the said DORTHA MAE KUSKIE, while the said JAMES ROBERT KUSKIE survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once vest in the said JAMES ROBERT KUSKIE, absolutely and in fee simple as his sole and separate property.
