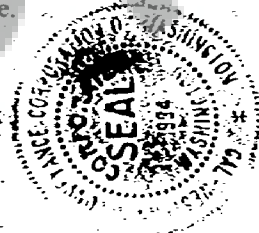
This discontinuance shall not be construed as waiving any breach or default under the
