DECREE OF DISSOLUTION
OF MARRIAGE

THIS MATTER came on regularly for hearing before the undersigned Judge of the Superior Court, on the date last shown below; the Petitioner appearing in person and by and through her attorney, IRVING L. DANE, and the Respondent not appearing, but having consented to the entry of a Decree of Dissolution at the time of accepting service of the Summons and Petition for Dissolution, and the Court having heard testimony and evidence and having made and entered its Findings of Fact and Conclusions of Law, and being fully advised in the premises, it is now

ORDERED, ADJUDGED AND DECREED that the marriage heretofore existing between the Petitioner and the Respondent be and the same is hereby dissolved; and it is further

ORDERED, ADJUDGED AND DECREED that the Petitioner will be awarded the custody of the minor children of the parties, namely: JASON LEE KRANK, born May 3, 1971; and JUSTIN JAMES KRANK, born October 29, 1974. The Respondent will have reasonable rights of visitation, including every other weekend, alternate family holidays, and two weeks during the summer vacations; and it is further

ORDERED, ADJUDGED AND DECREED that the Respondent will pay support in the amount of \$175.00 per month per child for a total of

11 A and B, which are incorporated herein by reference and made a part
12 hereof; and it is further

13 ORDERED, ADJUDGED AND DECREED that the debts of the parties
14 will be distributed as itemized on the attached Schedule C, which
15 is incorporated herein by reference and made a part hereof; and it
16 is further

17 ORDERED, ADJUDGED AND DECREED that the business interest of the
18 parties will be awarded as itemized on the attached Schedule D,
19 which is incorporated herein by reference and made a part hereof;
20 and it is further

21 ORDERED, ADJUDGED AND DECREED that each party will be awarded
22 his or her own pension, retirement and social security benefits,
23 if any; and it is further

24 ORDERED, ADJUDGED AND DECREED that the Respondent will be li-
25 able for all the children's medical, hospital and visual expenses,
26 orthodontia care; devices for health care, dental visits and care,
27 optometrists, ophthalmologists, glasses, eye check-ups and any
28 other expenses covered within the heading of "Medical Expenses".
29 All orthodonture is to be by written proposal to the husband detail-
30 ing the treatment planned. The treatment must be related to func-

1 covered expenses from his own income and monies and hold Petitioner
2 harmless thereon. Said liability for coverage shall terminate upon
3 the termination of the obligation for support for said minor child-
4 ren; and it is further

5 ORDERED, ADJUDGED AND DECREED that the Respondent will be re-
6 quired to continue in force a life insurance policy in the face
7 amount of \$50,000.00 on his life with Empire General, policy number
8 12766. In the event the Respondent is unable to continue said pol-
9 icy in force, he will be required to obtain an equivalent life in-
10 surance policy and to maintain said policy so long as there is an
