7. Protection of Lender's Rights in the Property. If Borrower fails to perform the covenants and agreements contained in this Security Instrument, or there is a legal proceeding that may significantly affect Lender's rights in the Property (such as a proceeding in bankruptcy, probate, for condemnation or forfeiture or to enforce laws or regulations), then Lender may do and pay for whatever is necessary to protect the value of the Property and Lender's rights in the Property. 13. Loan Charges. Beginning at the Northeast corner of the Northwest Quarter of the Southeast Quarter of Section 16, Township 3 North, Range 10 East of the Willamette Meridian, in the County of Skamania, State of Washington; thence South along the East line of said subdivisions 457.06 feet; thence North 85° 08' West 324 feet; thence North 02° 16' East 429.90 feet to intersect the North line of the Southeast Quarter of said Section 16; thence East along the North line of said Southeast Quarter 305.82 feet to the Point of Beginning.
