NON EXCLUSIVE LICENSE AGREEMENT

This agreement is made and entered into this <u>24th</u> day of <u>February</u>, 2000, by and between SKAMANIA COUNTY, hereinafter referred to as "Licensor", and UNITED TELEPHONE COMPANY OF THE NORTHWEST, hereinafter referred to as "Licensee", and its assigns and

WHEREAS, the Licensee has requested use of certain delineated portions of property for the purposes of placing underground communications cables and ducts.

NOW, THEREFORE, In consideration of the benefits and obligations set forth in this agreement, the parties agree as follows:

SECTION ONE GRANT OF LICENSE

Licensor hereby grants to Licensee the following privileges to use a portion of its property as follows:

A path running from the north property line to the south property line and extending eastward 10(ten) feet from the west property line of parcel 02-07-01-1-1-3200-00 in NE 1/4, NE 1/4, Sec 1, T-2-N, R-7-EWM, Skamania County, Washington.

SECTION TWO SPECIAL USE COMPLIANCE

Licensee shall comply with all county, state and federal laws and regulations concerning such usage.

SECTION THREE DURATION OF LICENSE

This License shall begin upon the execution hereof and shall continue until terminated as provided in this agreement. The Licensee may be assigned only upon the written approval of the Licensors.

SECTION FOUR INDEMNIFICATION OF LICENSOR

The Licensee shall indemnify and hold Licensor, it's officials and employees harmless against any claims, damages to other utility agencies, or injuries to third persons resulting from or arising out of the licensee's use of said properties. The Licensee shall further provide proof of insurance in the amount of \$1,000,000 narring Skamania County as additionally insured. To the extent work is done on the property, the licensee hereby expressly agrees to waive its immunity under RCW 51 (State Industrial Act) and to hold Skamania County harmless from any claims made by the licensee's employees, or the licensee's subcontractor's employees.

SECTION FIVE TERMINATION OF LICENSE

This License shall terminate upon ninety (90) days advance written notice by either party to the other. The Licensee agrees to return the properties to their original condition within ninety (90) days of termination of Agreement. The Licensor further reserves the right to immediately revoke this License at any time, without notice, if the Licensee violates any portion of this Agreement.

SECTION SIX CONSTRUCTION/INSPECTION

The Licensee shall not begin work under this agreement without first notifying the Skamania County Building & Grounds Office at least 48 hours prior to start of construction. The Licensee shall further notify the Skamania County Building & Grounds Office 24 hours prior to completion of work for final inspection.

SECTION SEVEN AFFECT OF PARTIES' RIGHTS

Nothing in this agreement shall be deemed or held to be an exclusive one and shall not prohibit the Licensor from granting other permits or franchise rights of like or other nature to other public or private utilities, nor shall it prevent the Licensor from using any of its roads, streets, or public places, or affect its right to full supervision and control over all or any part of them, none of which is hereby surrendered.

SECTION EIGHT WARRANTY OF TITLE

The Licensor does not warrant or guarantee the nature of its interest in the subject Property, nor does it guarantee that it has the authority to grant this License. The Licensee assumes all of the risk relating to the ownership of this property and agrees to indemnify and defend the Licensor from any challenges to this License Agreement or the improvements made hereunder.

SECTION NINE INTERFERENCE

Nothing in this agreement shall interfere with the County's full use or utilization of the property, or prevent the County from granting further licenses. If the Licensee interferes in any way with the drainage of the county property, the Licensee shall wholiy, and at its own expense, make such provisions as the Licensor may direct to remedy any such drainage problems.

SECTION TEN MERGER

This License and/or privilege shall not be deemed or held to be an exclusive one and shall not prohibit the Licensor from granting other permits, licenses, or permission to others, nor shall it prevent Licensor from using any of its property.
