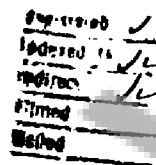

EXHIBIT "A"

A tract of land in the Northwest quarter of Section 14, Township 4 North, Range 7 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:
