RESOLUTION 2000- 12

(Creation of Skamania County Mosquito Control District Board of Trustees)

WHEREAS, residents of Cascade, Skamania and North Bonneville <sup>Precincts 01, 02</sup> voted to approve the establishment of a Skamania County Mosquito Control District (District) on February 12, 2000; and

WHEREAS, RCW 17.28.090 requires the Board of Commissioner to file an order of formation of the District with the Skamania County Auditor and a certified copy with the secretary of the state; and

WHEREAS, RCW 17.28.110 requires the Board of County Commissioners to appoint 4 members to a Board of Trustees within thirty days after the filing with the secretary of state of the certified copy of the order of formation establishing the District; and

WHEREAS, RCW 17.28.110(2) requires the City of North Bonneville to appoint one member to a Board of Trustees within thirty days after the filing with the secretary of state of the certified copy of the order of formation establishing the District; and

WHEREAS, RCW 17.28.110 (2) states that if the District is situated entirely in one county and includes both incorporated and unincorporated territory one member shall be appointed from each commissioner district lying wholly or partly within the District by the county commissioners of the county, and one member from each city, the whole or part of which is situated in the District, by the governing body of the city; but if the District board created consists of less than five members, the county commissioners shall appoint from the District at large enough additional members to make a board of five members; and

WHEREAS, RCW 17.28.120 requires that the members appointed by the County be registered voters and residents of the County and that they reside within the District; and

WHEREAS, RCW 17.28.120 requires that the members appointed by the City be registered voters and residents of the City and that they reside within the District; and

WHEREAS, RCW 17.28.130 requires that if the total membership is an odd number, the terms of a bare majority of the members will expire at the end of one year and the terms of the remainder at the end of two years from the second day of January of the year next succeeding their appointment (i.e. if appointed April 10, 2000 for a 1 year appointment, the Board of Commissioners would need to reappoint on January 2 of 2002). The term of each subsequent member is two years from and after the expiration of the term of his/her predecessor.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners hereby adopts the following schedule to appoint members to the Board of Trustees:

Position No. 2	At Large within the District	1 year
Position No. 3	At Large within the District	2 years

BE IT FURTHER RESOLVED that the term of each subsequent member is two years from and after the expiration of the term of his predecessor; and

BE IT FURTHER RESOLVED that pursuant to RCW 17.28.090, this resolution constitutes an order and will be filed with the Skamania County Auditor, along with a certified copy to the secretary of the state; and

BE IT FURTHER RESOLVED Skamania County will advertise for and solicit four (4) qualified residents to be appointed to the Board of Trustees; and

BE IT FURTHER RESOLVED Skamania County will request the City of North Bonneville to advertise and solicit one qualified resident to be appointed to the Board of Trustees; and

BE IT FINALLY RESOLVED that when the Board of Commissioners and the City of North Bonneville have appointed the members to the Board of Trustees and the County shall file a Certificate of Incorporation of the District with the secretary of the state.
