LICENSE AND SPECIAL USE PERMIT

WHEREAS, pursuant to that certain license agreement dated July ____, 1996 (attached), between David M. and Kathy L. McKenzie (McKenzies) and Richard J. and Diane M. Lang (Langs). The McKenzies are required to relocate, at their own cost, an existing waterline crossing the McKenzies' ownership of the western portion of Lots 4, 5 and 6 of Block 1 of the Cascades Addition to the Town of Stevenson, as recorded in Book A of Plats at Page 62 in the Skamania County Auditor's Office, State of Washington; and

WHEREAS, the Langs' ownership is that eastern portion of Lots 4, 5 and 6 of Block 1 of the Cascades Addition to the Town of Stevenson, as recorded in Book A of Plats at Page 62 in the Skamania County Auditor's Office, State of Washington; and

WHEREAS, the McKenzies, and their assigns, pursuant to that contract desire to relocate this waterline and to attach to the residence of the Langs, which will cross the Langs' western portion of Langs' ownership; and

WHEREAS, the McKenzies, and their assigns, will at their own cost tap into the existing City of Stevenson water main along Roselawn Street and assure that the Langs are connected to the city water with equal or greater water service than before; and

WHEREAS, the McKenzies, and their assigns, will at their own cost install a water meter at the southwest corner of the Langs' property to serve Langs' property; and

WHEREAS, the Langs grant to the McKenzies, and their assigns, a license to install a waterline and a water meter upon the Langs' ownership to satisfy the McKenzies' contractual requirement; and

WHEREAS, the waterline is to be relocated on the property owned, occupied and resided upon by the Langs; and

WHEREAS, the waterline is to be installed to meet the minimum requirements by City of Stevenson code; and

WHEREAS, the McKenzies, and their assigns, are responsible for obtaining all of the necessary permits and licenses to perform this work; and

WHEREAS, in the installation of a said waterline, the upmost care is to be taken not to disturb vegetation along the boundary line between the Langs and the McKenzies; and

WHEREAS, in the installation of a said waterline, the upmost care is to be taken not to disturb vegetation along the west side of the Langs' house; and

WHEREAS, the McKenzies, and their assigns, will not disturb the landscape rock boarder along and north of the sidewalk along the Langs' south property line; and

WHEREAS, the McKenzies, and their assigns, will connect the new waterline to the new water meter.

NOW, THEREFORE, Richard and Diane Lang, upon the terms and conditions described below, hereby grants to David and Kathy McKenzie a license to use that portion of land necessary to install a water meter and a waterline.

Terms and Conditions of License

- The Langs hereby grant to the McKenzies, and their assigns, a license for reinstallation of a water meter and a waterline confined to and area of the Langs' property which is described as: the west 9.50 feet of the south 55.00 feet of Tax Parcel #03-07-36-3-4-4000-00, said tax parcel being the western portion of Lots 4, 5 and 6 of Block 1 of the Cascades Addition EXCEPTING the west 1.50 feet.
- The McKenzies agrees that they are solely responsible for making whatever repairs that are 2. necessary to bring the contour of the ground to it original shape and that they will obtain all necessary licenses and permits and will comply with all laws, regulations and ordinances.
- 3. The McKenzies agrees not to move, alter or remove any plants (other than lawn) on the site.
- 4. The McKenzies agrees not to leave an open ditch or open hole upon the ground over night nor leave any such openings unattended during the nondaylight hours.
- The Langs reserves the right to revoke this license at anytime with 24 hours notice. In any 5. event, this license will expire upon the sooner of the installation of the waterline or April 25, 1998.
- The McKenzies, and their assigns, will protect, save and hold harmless the Langs from all claims, actions, costs, damages or expenses of any nature whatsoever by reason of the acts or omissions of the McKenzies, their agents, employees and/or assigns, out of or in connection with any acts or activities under by this license.

LICENSE AGREEMENT

This agreement by and between DAVID M. McKENZIE and KATHY L. McKENZIE, husband and wife, as "Licensor", and RICHARD J. LANG and DIANE LANG, husband and wife, as "Licensees",
