PARTIAL ASSIGNMENT OF EASEMENT

WHEREAS, by Right of Way Easement, dated July 27, 1970, recorded in Skamania County, Washington in Book 61 of Deeds, page 1000, PACIFIC POWER & LIGHT COMPANY, a Maine corporation, conveyed to WEYERHAEUSER COMPANY, a Washington corporation, a nonexclusive, perpetual, assignable and easement to construct, maintain and use certain roads (herein "Easement Roads") over and across portions of the NEWNWY of Section 25, Township 7 North, Range 5 East, W.M. in Skamania County, Washington;

WHEREAS, WEYERHAEUSER COMPANY, by Warranty Deed, dated October 12, 1999, recorded in said Skamania County in Book 194, page 295, conveyed to FRUIT GROWERS SUPPLY COMPANY, a California corporation, certain lands (herein "FGS Lands") in Sections 1, 9, 10, 11, 12, 13, 15 and 23, all in Township 7 North, Range 5 East, W.M., Skamania County, Washington, which lands are accessed by the above described Easement Roads; and

WHEREAS, WEYERHAEUSER COMPANY and FRUIT GROWERS SUPPLY COMPANY agree that those easement rights acquired pursuant to said Right of Way Easement that provide ingress to and egress from said FGS Lands shall be assigned, set over and transferred to FRUIT GROWERS SUPPLY COMPANY.

NOW THEREFORE, WEYERHAEUSER COMPANY, a Washington corporation, hereby assigns, sets over and transfers unto FRUIT GROWERS SUPPLY COMPANY, a California corporation, those rights under said Right of Way Easement providing access to and from said FGS Lands. WEYERHAEUSER COMPANY shall retain all other rights under said Right of Way Easement providing access to its remaining land, timber and mineral ownership in the vicinity.
