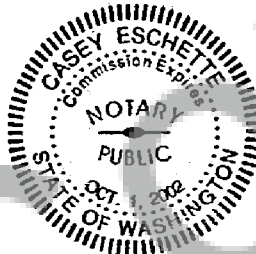

The West half of the Northwest Quarter of the Northeast Quarter of Section 36, Township 4 North, Range 7W East of the Willamette Meridian, County of Skamania, State of Washington, described as follows:

EXCEPTING therefrom the following:

Beginning at the Southwest corner of the Northwest Quarter of the Northeast Quarter of the said Section 36; thence East 660 feet; thence North 198 feet; thence West 660 feet; thence South 198 feet to the Point of Beginning;

AND EXCEPT the following tract: Beginning at the Northeast corner of the West half of the Northwest Quarter of the Northeast Quarter of the said Section 36; thence South 420 feet; thence West 212 feet; thence North 420 feet; thence East 212 feet to the Point of Beginning;
