This deed is for the purpose of securing performance of each agreement of Grantor herein contained, and payment of the sum of Seventy-Five Thousand And 00/100 Dollars (\$75,000.00) with interest, in accordance with the terms of a promissory note of even date herewith, payable to Beneficiary or order, and made by Grantor, and all renewals, modifications and extensions thereof, and also such further sums as may be advanced or loaned by Beneficiary to Grantor, or any of their successors or assigns, together with interest thereon at such rate as shall be agreed upon.

To protect the security of this Deed of Trust, Grantor covenants and agrees:

- 1. - 1. In the event any portion of the property is taken or damaged in an eminent domain proceeding, the entire amount of the award or such portion thereof as may be necessary to fully satisfy the obligation secured hereby, shall be paid to Beneficiary to be applied to said obligation.

ADDENDUM TO DEED OF TRUST

3(a) Application of Insurance Proceeds. In case of loss by fire or other hazards insured against under section 3 herein, Grantor may elect either to restore or not to restore the damaged property. If Grantor chooses to restore the property, and provided that Grantor is not in default under the Deed of Trust, Beneficiary shall apply the insurance proceeds to the reasonable cost of repair, restoration and improvement of the property. If Grantor notifies Beneficiary in writing that it elects not to restore the damaged property, Beneficiary shall apply the insurance proceeds toward payment of the remaining indebtedness secured by this Deed of Trust. Any insurance proceeds remaining after the repair, restoration and improvement of the property shall be applied toward payment of the remaining indebtedness secured by this Deed of Trust.

4. Default.
