

WARRANTY DEED

MELVIN S. LOCKE, JR. and CHERYL RAE LOCKE, husband and wife, of Washougal, Washington, Grantors, under the provisions of the Columbia River Gorge National Scenic Area Act of November 17, 1986 (P.L. 99-663; 100 Stat. 4274), for and in consideration of an exchange of National Forest System land, the receipt of which is hereby acknowledged, and a cash equalization payment of ONE THOUSAND DOLLARS (\$1,000) being paid by the Grantors to the Grantee, do hereby convey and warrant to the UNITED STATES OF AMERICA, Grantee, and its assigns, the following described real property situate in the County of Skamania, State of Washington, free of encumbrances except as specifically set forth herein:

I. 1 N., R. 6 E.,

sec. 6, NE1/4SW1/4SW1/4NW1/4;

AND, the east 200 feet of the west 880 feet of that portion of the N1/2S1/2NW1/4 of sec. 6, lying northerly and westerly of the centerline of the existing Easement Access Road constructed by Bonneville Power Administration;

AND, that portion of sald sec. 6 of T. 1 N., R. 6 E., described as follows:

BEGINNING at the southwest corner of the northwest quarter of sec. 6, T. 1 N., R. 6 E., W.M., Skamania County, Washington;
