CLAIM OF LIEN
 Pursuant to 60.24 RCW

CHILTON & PRESTON, INC., Claimant v. QUALITY VENEER & LUMBER, INC.

Notice is hereby given that CHILTON & PRESTON, INC. of Cowlitz County, state of Washington, claims a lien upon the timber, logs, lumber and stumpage of Quality Veneer & Lumber, Inc. of Odell, Oregon, being about 5,452.96 tons in quantity, which were cut or manufactured on the S2090 road in Skamania County, state of Washington, more particularly described as Section 21 and 28, Township 6 North, Range 5 East, are marked with red paint on both ends of said logs with the brand H-7590 utilizing the 4N branding hammer, and are now lying at Hanel Lumber Company in Odell, Oregon and Pacific Fibre in Longview, Washington, for labor performed upon and assistance rendered in falling, bucking, yarding, loading and hauling said timber, logs, lumber and stumpage; that the name of the owner or reputed owner is Quality Veneer & Lumber, Inc.; that Quality Veneer & Lumber, Inc. employed said Chilton & Preston, Inc. to perform such labor and render such assistance upon the following terms and conditions, to wit:

That said Quality Veneer & Lumber, Inc. agreed to pay said Chilton & Preston, Inc. for such labor and assistance on the 10th and 25th of each month at the rate of \$22.50 per ton for falling, bucking, yarding and loading timber and logs delivered to Hanel Lumber Company in Odell, Oregon, \$13.00 per ton for hauling the logs to Hanel Lumber Company in Odell, Oregon and \$26.00 per ton for falling, bucking, yarding, loading and hauling the timber and logs to Pacific Fibre in Longview, Washington; that said contract has been faithfully performed and fully complied with on the part of said Chilton & Preston, Inc., who performed labor upon and assisted in falling, bucking, yarding, loading and hauling said timber, logs, lumber and stumpage for the period of two months; that said labor and assistance were so performed and rendered upon said property located on S2090 in Skamania County, state of Washington, more particularly described as Section 21 and 28, Township 6 North, Range 5 East, between the 2nd day of June, 2000 and the 2nd day of August, 2000; and the rendition of said service was

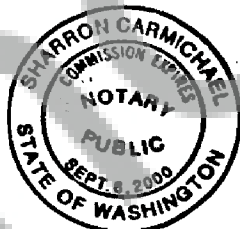
closed on the 2nd day of August, 2000, and sixty days have not elapsed since that time; that the amount of claimant's demand for said service is \$240,944.79; that no part thereof has been paid except \$70,488.83, and there is now due and remaining unpaid thereon, after deducting all just credit and offsets, the sum of \$170,455.96, in which amount Chilton & Preston, Inc. claims a lien upon said timber, logs, lumber and stumpage. Chilton & Preston, Inc. claims a lien on all said timber, logs, lumber and stumpage now owned by said Quality Veneer & Lumber, Inc. of Odell, Oregon to secure payment for the work and labor performed in obtaining or securing the said logs, spars, piles, or other timber, lumber, or shingles herein described.
