That portion of the East Half of the Southwest Quarter of Section 27, Township 2 North, Range 5 East, W. M., described as follows or as constructed:

COMMENCING at the Southwest corner of the Southwest Quarter of said Section 27; thence South 87°27'40" East along the South line thereof a distance of 1361.56 feet to the Southwest corner of the East half of said Southwest Quarter; thence North 0°10'00" West along the West line of said East half, a distance of 396.92 feet to centerline station P.O.T. 167408.68 of Washougal River Road as shown on the County Engineer's plan for County Road 1106, Skamania County, Washington, dated March 24, 1969; thence North 35°45'30" East along said road centerline, a distance of 411.04 feet to centerline station 171+19.92 of said plan, a point of curvature of a 286.48 foot radius tangent curve to the right; thence continuing northeasterly along said curve through a central angle of 05°16'18", an arc distance of 26.36 feet; thence North 48°58'12" West, along a prolongation of a line radial to said curve, a distance of 35.30 feet to a point on the West right-of-way margin of Washougal River Road opposite centerline station 171+46.3 of said plan and the POINT OF BEGINNING:

Said drainage system shall remain the property of the Grantee, and that the Grantee shall have the right of ingress and egress over the adjacent lands of the Grantor(s) for the purpose of exercising the rights hereby granted.

All rights hereunder shall cease when the Grantee abandons or removes said drainage system.


