- 1. To keep the property in good condition and repair; to permit no waste thereof; to complete any building, structure or improvement being built or about to built thereon; to restore promptly any bull and, structure or improvement thereon which may be damaged or destroyed; and to comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting the property.
- 2. To pay before delinquent all fawful taxes and assessments upon the property; to keep the property free and clear of all other charges, liens or encumbrances impairing the security of this Deed of Trust.
- 3. To keep all buildings now or hereafter erected on the property described herein continuously insured against loss by fire or other hazards in an amount not less than the total debt secured by this Deed of Trust. All policies shall be held by the Reneficiary; and be in such companies as the Beneficiary may approve and have loss payable first to the Beneficiary is is interest may appear, and then to the Grantor. - 2. By accepting payment of any sum secured hereby after its due date. Beneficiary does not waive its right to require prompt payment when due of all other sums so secured or to declare default for failure to so pay.
