Carey by contract dated November 26, 1951, and recorded in Book 35, at page 60, Deed Records of said County, and EXCEPT THEREFROM that certain tract of land sold to Ruth Steuer by contract dated November 1, 1952, and recorded in Book 36, at page 96, Deed Records of said County; and

AGREEMENT (FERMISSION FOR FISHING ONLY) I

EXCEPT THEREFROM that certain tract of land and easement conveyed to the State of Washington by Deed dated July 1, 1955, recorded in Book 40, at pages 9 and 10, Deed Records of said County.

TOGETHER WITH water rights appurtenant thereto.

Said permission is binding only as long as grantor and/or her heirs own the subject property and shall not be any encumbrance upon the land in the event the property is conveyed to any third party or parties. This permission is further personal to the grantee(s) herein named only and shall not be assigned to any third party or parties.

This agreement is given to grantee(s) for the right and privilege to fish in and on the above certain tract of land owned by the grantor, and specifically along the Washougal River. Grantees specifically acknowledge the legal title of grantor to the above-described property and agree never to deny such title or to claim title in grantee's name.

Grantee further shall exercise the rights herein granted at grantee's own risk, and agrees to hold grantor harmless from any claims or damages against grantor for any injuries or damages suffered on account of the exercise of such grant herein, regardless of the fault or negligence of the grantor, and grantee shall further indemnify grantor against all liability for damages and expenses resulting from, arising out of, or in any way connected with, the exercise of the privilege by grantee(s).
