further court intervention or supervision.

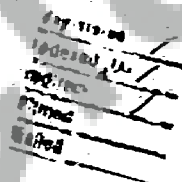

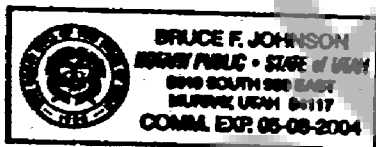
