FIRST:

- (A) The Settlor hereby transfers, assigns, conveys, and delivers to the Trustee the property described in the annexed Schedule A, which is the Settlor's separate property, receipt of which the Trustee acknowledges.
- (B) Such property transferred to the Trustee and any other property hereafter transferred to the then Trustee and deemed acceptable by the Trustee shall be held in trust for the benefit of the Settlor pursuant to the following terms and conditions.

SECOND:

Upon the Settlor's death, the Trustee shall distribute the then property of the trust pursuant to any testamentary bequest, devise, or gift of the Settlor, or, in the alternative, if the Settlor may die intestate, distribute the then property of the trust pursuant to the laws of intestate succession.

THIRD:

The Trustee, including any successor Trustee hereunder, shall have all the rights, powers, and duties given pursuant to the "POWER OF ATTORNEY DURABLE" of Joan Mason, dated November 6,1998, as well as those rights, powers, and duties given by law on the date hereof, including those set forth in RCW Title 11.
